In general, I believe that healthcare is one of the biggest obstacles to the longterm success of small businesses. Too many business owners are left with the choice of paying for costprohibitive plans or to go without coverage, for themselves and their employees. Healthcare costs should not be a barrier to entrepreneurship. which is one reason I fight for universal healthcare.

After the first round of COVID-19 relief programs passed, many small business owners found that they could not access the resources offered by programs like the Payroll Protection program - that the money available was gobbled up by big companies that could afford to keep teams of accountants and lawyers on staff. Any program enacted in Minnesota should accessible both to those who cannot afford to retain experts and to those who speak English as a second language.

George Floyd's murder has pushed the world into more deep conversations around race and policing. One of the components of anti-racist work is in education, and in specifically ethnic studies. Ethnic studies provides students the opportunity to learn and reflect on their racial identity through a historical lens. Do you support mandated ethnic studies as a high school graduation requirement?

Yes.

COVID-19 has shifted many polling places for this past Primary Election. Many organizations and individuals are advocating for absentee voting by mail as well. Absentee voting by mail can be confusing to many and even more so when you can't read or write English well. Many of our Asian community members may not have assistance or language skills to complete an absentee ballot by mail. How do you hope to shift access to the polls for all?

I believe that loosening the restrictions around translating & witnessing absentee ballots was a good first step. This year even more than others, it is also important to expand the hours & locations of early vote centers. The hours of most centers are not accessible to people who work multiple jobs, work night shifts, who run a business with few employees, or who do not otherwise have flexibility between 9am - 5pm. And the main location in Saint Paul is at the Ramsey County building on Plato Blvd - it's a difficult spot to access by public transportation. From my experience, it is easier to provide support to voters - translation, taking the time to explain the process - at an early vote center than at the polls. If those centers are more embedded in communities, then it becomes much easier to provide support to voters.

My campaign is currently creating a series of graphics answering commonly asked questions about early voting, and are working to get those materials translated so that they are accessible.
